FROM THE SUPERVISOR

FOOD PANTRY: Nunda Township hosts a food pantry run by volunteers from the First Church of Crystal Lake. This event is held on Friday mornings from approximately 9:00 a.m. to Noon at the Nunda Town Hall. McHenry County residents in need are welcome.

SOLID WASTE REMOVAL: In March 2014, Nunda voters passed a referendum allowing Nunda Township to contract for residential waste and recycling services in our unincorporated areas. In January 2015, Nunda sent an extremely detailed Request for Proposal to the seven solid waste haulers that serve our community. We received bids from four of them. On March 12, 2015, after thorough assessment and consideration of pricing and services offered, the Nunda Township Board unanimously selected Waste Management to be the single provider of solid waste hauling services to approximately 4500 residents within unincorporated Nunda Township. The four year contract will become effective on May 1st and residents will be billed directly from Waste Management.

In addition to refuse and recycling pickup, the service and pricing will include yard waste pickup, holiday tree removal, and leaf vacuuming in the fall. If you reside in the area covered by this contract, you will be receiving a joint mailing from Waste Management and Nunda Township. Please pay particular attention to the options for cart sizes / pricing and follow the directions to make Waste Management aware of your desired Service Plan by Wednesday, April 8th. This will allow Waste Management to bring you the correct size carts during the last week in April.

Nunda Community Garden Update – We will be breaking ground soon! The Nunda Supervisor's Office, in conjunction with the Northern Illinois Food Bank, the U of I Extension office in Woodstock, First Church of Crystal Lake volunteers and a local Girl Scout troop will soon to plant a garden on otherwise unutilized Nunda Township grounds. This will supplement the Northern Illinois Food Bank's efforts to supply fresh vegetables to local food pantries. Our Vision is to fight hunger by engaging, educating and empowering our community. This will be a community learning project and we would like to see involvement from other groups as well. Volunteer opportunities will be available for groups and individuals. ROAD DISTRICT NEWS FROM THE COMMISSIONER'S DESK

Snow and Ice Removal Update and Improvements – Salt brine is a salt water mixture that we inject onto the road salt as it comes off the truck. This product accelerates the activation of the road salt. This past fall, Nunda's crew built our own brine production facility. We recycle the waste water from washing our plow trucks to make the brine after it goes through a filtering process to remove any impurities. We were previously paying \$.36 per gallon for this product and paying \$.14 per gallon to have our waste water disposed of. Now, it costs us approximately \$.15 per gallon, including labor and materials, to make our own brine. When you factor in the \$.14 per gallon for not having to haul away wash bay water, our final cost to produce one gallon of salt brine is **\$.01** (one penny per gallon). Given the gallons used and our capital outlay, it will take 2-3 years to recover the investment, depending on winter conditions,

Polluted Runoff – Nunda Township Road district maintains stormwater systems along its roads and highways by managing the quality and quantity of stormwater discharge in compliance with NPDES regulations. Following all essential procedures and requirements, the Road District is working to preserve, protect, and improve Nunda Township's waters.

As stormwater flows over driveways, lawns, and side-walks, it picks up debris, chemicals, dirt, and other pollutants. The polluted water flows through a storm sewer system or directly to a lake, stream, river wetland, or coastal water. This drainage discharges untreated into the bodies of water we use for swimming, fishing and providing drinking water. Homeowners can do their part in protecting our waters by keeping common pollutants like pesticides, pet waste, grass clippings, and automotive fluids off the ground with the following **Healthy Household Habits for Clean Water:**

Vehicle and Garage

Use a commercial car wash or wash your car on a lawn or other unpaved surface to minimize the amount of dirty, soapy water on the pavement.

Check your car, boat, motorcycle, and other machinery for leaks and spills. Make repairs as soon as possible.

Clean up spilled fluids with an absorbent material like kitty litter or sand. Dispose of the absorbent material properly. Recycle used oil and other automotive fluids at participating service stations.

Lawn and Garden

Use pesticides and fertilizers sparingly. When use is necessary, use these chemicals only in the recommended amounts. Avoid application if the forecast calls for rain.

Sweep up yard debris, rather than hosing down areas. Compost or recycle yard waste when possible.

Cover piles of dirt and mulch being used in landscaping projects to prevent these pollutants from blowing or washing off of your yard. Vegetate bare spots in your yard to prevent soil erosion.

Home Repair and Improvement

Before beginning an outdoor project, locate the nearest storm drains. Protect them from debris and other materials.

Sweep up and properly dispose of construction debris such as concrete and mortar.

When using paints, solvents, and cleaners follow directions on the label. Clean up spills immediately and dispose of the waste safely. Store contents properly to avoid leaks and spills. Clean paint brushes in a sink, not outdoors. Filter and reuse paint thinner when using oil-based paints.

Properly dispose of excess paints through a hazardous waste collection program or donate it to local organizations.

Purchase and use nontoxic, biodegradable, recycled, and recyclable products whenever possible.

Reduce the amount of paved area by increasing the vegetation in your yard. Consider directing downspouts away from paved surfaces onto lawns.

Swimming Pool and Spa

Drain your swimming pool only when a test kit does not detect chlorine levels.

Properly store pool/spa chemicals to prevent leaks & spills.

Septic System Use and Maintenance

Have your septic system inspected by a professional at least every 3 years, and the septic tank pumped every 3 to 5 years. Do not drive/park vehicles on septic system area.

Flushing household chemicals like paint, pesticides, oil, and antifreeze can destroy the biological treatment taking place in the septic system. Flush responsibly.

2015 is a General Reassessment year (also known as a Quadrennial). Illinois statute requires that every four years, the Assessor must review and reassess all property in their jurisdiction. Our staff will be studying the last three years of sales data to ensure that neighborhoods are valued fairly and equitably. Adjustments, if necessary, will be made as needed, per Illinois State Status. Assessment notices will be mailed out later this year.

Spring is right around the corner, and you may be thinking about adding a deck, pool or room addition to your home this season. However, don't forget to apply to your local building authority for a permit before you begin construction.

The **Illinois Homestead Improvement Exemption** allows homeowners to add certain improvements without an immediate tax liability. After the project is completed, a maximum of \$25,000 of assessed value (\$75,000 in market value) may be deferred under this program for four years, this exemption will defer any increase in the assessment of your property due to the added improvement. The Township Assessor's office initiates this program.

Pick up a water test kit, at the Supervisor's office, any day during regular business hours and drop off samples to be tested on any Tuesday (excluding holidays) between 7:30 - Noon. Fees will be billed by McHenry County Department of Health. During the months of April and August the cost for a standard water test is reduced to \$18.00.

ADDITIONAL ROAD DISTRICT NEWS

- **Roads being paved this year:** Hillside Road (Walkup to Oak Street), Covered Bridge Subdivision Phase 2, Sherwood Drive, Swarthmore Road and side streets, Squaw Creek Valley Subdivision, Shenandoah Subdivision, Nish Road, Lakeview Drive, Blue Island Avenue, Thomas Court, Forestwood Drive, Beachway Street, and Porten Road. Visit our website: www.nundaroaddistrict.com, to see when your street is scheduled for an upgrade.
- **Sand Bags:** While we always hope we won't need them, the Road District has, in stock, approximately 80,000 sandbags ready to be filled if necessary. Bags are available with a minimum one (1) day notice.
- **Thinking of having your driveway repaved?** If you live on a road maintained by the Township, please call us to come out and inspect your culvert. It makes no sense to put new pavement over a rusted out culvert. We will come out inspect the culvert and replace it if needed.
- **Mulch:** You can pick up mulch 24-7 at the recycle center. If you require a greater quantity, we can load your truck or trailer in the back of the facility on Saturdays from 7:00 a.m. to 12:00 p.m.
- **Routine Cleanups:** Our crews will be out soon to clean up and touch up after the plow season. Mailboxes that were damaged by our plows will be repaired this spring.
